### **End Dismemberment Petition Drive**

The Michigan Bureau of Elections resumed the vetting process for the petition drive to end dismemberment abortions. The bureau set June 1 as the deadline for challenges to the signatures. It's been nearly a year since we began collecting signatures to end the violent late-term dismemberment abortion procedure. The petition drive has overcome an exhaustive list of challenges, now including a global pandemic. If enough valid signatures remain following the challenge period, the petition will be certified by the Board of State Canvassers and the dismemberment ban will be sent to the legislature for consideration with a 40-day time limit. Majority votes in the House and Senate will pass the dismemberment ban into law without Governor Whitmer's signature. Initiated legislation that isn't passed into law is placed on the general election ballot for a public vote.

# Who is Really Killing Grandma?

Right to Life of Michigan isn't killing grandma; Governor Whitmer might be, though. Since the early days of the pandemic, Right to Life of Michigan has criticized Governor Whitmer for the separate and unfair treatment she is giving to abortion facilities. The Governor is privileging elective abortions over truly necessary medi-



cal procedures deemed "not essential." Other than that, we haven't weighed in on other pandemic response policies.

Despite staying in our lane, we have received some ongoing criticism from abortion supporters. The comments all go something like this: "You aren't speaking out against reopening businesses as the sacrifice of the aged, sick, homeless, etc." It is not just limited to e-mails and mean tweets. During a debate on the floor of the Michigan Senate over Governor Whitmer's legal authority, Senator Curtis Hertel, Jr., had some harsh words for pro-lifers.

Sen. Hertel said, "I don't want to hear another damn thing about the sanctity of life from the other side of the aisle again. Apparently, life is sacred unless it stops the almighty dollar or your golf game."

Well, since they keep asking for our opinion, how about this? Consider Michigan's nursing homes. Sadly, Michigan citizens have not been given death figures from our nursing homes yet. The median age of deaths due to the coronavirus in Michigan is 76, so we can only guess the toll in our nursing facilities has been catastrophic.

It has been the policy of Governor Whitmer's Administration to place seniors stricken with the coronavirus into "regional hubs," which include nursing homes. They are paying these nursing homes \$5,000 a bed to purposefully bring the virus into their buildings.

Since some other states are transparent and publish their nursing home death figures, we are learning what a foolish policy this is. It was blind hope that separation procedures inside the nursing homes would protect our most vulnerable citizens. Notably, New York Governor Andrew Cuomo ended this practice in his state a few days ago.

However, Whitmer's Administration still seems committed to it. In a story from WDIV on May 11, Michigan's Chief Medical Executive Joneigh Khaldun defended putting the coronavirus into nursing homes: "It's a good move, a good step to make these regional hubs, and I think as we move forward, we have to look at making sure we're really implementing best practices, looking to other best practices across the state."

A good move?

Right to Life of Michigan has dealt with many end of life issues over the years, which disproportionally affect our seniors. Usually seniors are at risk of euthanasia or rationing of medical care because of a callous attitude toward the value of their lives. Sometimes it's motivated by greed from family members, or a twisted sense of doing patients and their families a favor from medical providers. Those are value problems.

Putting coronavirus patients into nursing homes? Perhaps that is a value problem, but it's really best explained as a competence problem. We are sure many in Governor Whitmer's Administration thought her nursing home policy sounded good on paper, when we thought our entire hospital system was at risk of collapse. However, the numbers are in. Our hospitals are not overwhelmed. The dedicated coronavirus field hospital set up in the building formerly known as Cobo Hall is shuttered. Our elderly family members are overwhelmingly the highest risk category for this virus, making up more than half the dead.

So, since some of you keep asking, we're weighing in, mostly from a standpoint of basic common sense: Right to Life of Michigan believes

ello all! My name is Leann Clink, I am the nurse manager for Spero Center in Port Huron. Our office is the only pregnancy center in St. Clair County, but there are 16 more like us in Southeast Michigan. It is our great pleasure to inform you that the Blue Water Pregnancy Care Center changed our business name to Spero Center on March 15, 2019. Spero (pronounced sparrow) means HOPE in Latin. For 33 years, we have offered HOPE to our young moms and dads, and our phone number spells HOPE (985-HOPE). This was our inspiration for the new name and the image of a bird inspires rising above circumstances, freedom and HOPE. We continue to specialize

in pregnancy diagnosis and options with compassion and practical help. All our services are free: pregnancy tests, ultrasounds, options counseling, pre-natal and parenting classes, baby items, community referrals and much more. We help nearly 800 men and women every year until their baby is 24 months old.

I wanted to talk about remaining open and being essential during this time of COVID infection. Our pregnancy center has been able to remain open due to our board and medical director wanting to serve women during shelter-in-place, especially since abortion clinics in Michigan remain open and performing abortions. This has been a tremendous blessing for our clients. We have seen a slight increase in pregnancy tests; however, we have had to limit our ultrasound services per medical director request to follow social distancing guidelines whenever possible.

One of the things, however, that has been exciting is our classes. Last year, we started doing limited virtual classes through BrightCourse, part of Heritage House. These prenatal and parenting classes are sent to our clients with their permission either by text message or email. They watch a short video and answer questions. The information is evidence-based and Christ-centered, a win-win.

We have been able to connect with our clients during this time of fear and uncertainty and forge relationships, sometimes stronger than before. This is a blessing that was not foreseen when all of the changes started. We have recently added a Zoom Bible class to our list of virtual client classes too. Our virtual classes have tripled in size compared to face-to-face, in-person classes. It is a blessing to be an essential service reaching out and "touching" our clients in a time when reaching out is not easy or encouraged.

Moving forward, we will be continuing on with virtual classes and be looking for new ways to engage our culture so that the next time we come up against some infectious disease or other obstacle we again will conquer it and find new ways to care for clients. After all, that is what nursing does...we care and look for ways to assist clients.

# Planned Parenthood Abortion Business Lays Off One-Third of Its Staff, Cutting 285 Employees

even the abortion chain Planned Parenthood is struggling during the coronavirus crisis. Its Greater New York affiliate recently admitted that it had to lay off nearly one-third of its staff this spring as patient visits dropped by more than half, Crain's New York Business reports.

This is good news for life. Planned Parenthood's "core mission" is abortions, and abortions are not essential or necessary. They are life-destroying procedures that kill unborn babies and often harm mothers.

According to the report, Planned Parenthood of Greater New York laid off 135 employees and furloughed or reduced the hours for 150 more. Laura McQuade, CEO of the New York affiliate, said their in-person visits are down by approximately 70 percent, and donations are down, too.

The organization has continued to work with public health officials in the city and at the state level. It's been taking referrals for abortion care from hospitals that have been unable to provide it during the crisis. Still, the report and others suggest the abortion chain is struggling. They offer a glimmer of hope that America's largest abortion chain may be beginning to crumble.

Across the world, more than 5,000 clinics affiliated with the International Planned Parenthood Federation (IPPF) also closed in connection to the coronavirus pandemic. In April, IPPF reported 5,633 clinics in 64 countries closed, and of its 132 member associations, 23 reported "reduced availability" of abortions. The pro-abortion organization, founded by Margaret Sanger, does abortions all across the world. It reported 5.3 million "abortion-related services" in 2018 alone. These closures mean more unborn babies and mothers may be spared from the pain and death of abortion. The good news for women and their unborn children is they can now receive legitimate pregnancy care and support. Anyone needing assistance can go to OptionLine.

### Federal Appeals Court Again Upholds Trump's Pro-Life Rule Defunding Planned Parenthood Abortion Biz

A /hen an 11-member panel of the 9th U.S. Circuit Court of Appeals affirmed a threejudge panel's decision upholding the Trump Administration's "Protect Life Rule," the state of California asked the Court to rehear its en banc decision. The decision had vacated court decisions entered in California, Oregon, and Washington which blocked enforcement of the rule. [On May 8, 2020], the 9th Circuit refused to reconsider its 7-4 decision to uphold, according to the Court House News Service. The judges simply announced that the Court "has voted to deny the Petition of Plaintiffs-Appellees."

Derided as a "gag rule," the Trump Administration's Protect Life Rule did nothing more than require recipients of Title X family planning money not to refer clients for abortion as a method of family planning or co-locate with abortion clinics. Planned Parenthood opted out of the Title X program rather than accept the limitations which were clearly intended by Congress when it created the program in 1970.

At the time of the February 24 en blanc decision, Mollie Timmons, a Department of Justice spokesperson, said, "Congress has long prohibited the use of Title X funds in programs where abortion is a method of family planning and HHS's recent rule makes that longstanding prohibition a reality."

Ed Whelan, in a very helpful post, nicely summarized the 9th Circuit's holding in California v. Azar):

In her majority opinion, Judge Ikuta explains that the Title X regulations are similar to those upheld by the Supreme Court in Rust v. Sullivan in 1991, and that they are in fact "less restrictive in at least one important respect: a counselor providing nondirective preanancy counseling 'may discuss abortion' so long as 'the counselor neither refers for, nor encourages, abortion." There therefore "is no 'gag' on abortion counseling" (even if one were to adopt the dubious position that a refusal to provide funding amounts to a "gag"). Ikuta rejects arguments that two intervening congressional enactments render Rust's holding no longer valid (pp. 32-48) and that the regulations are inconsistent with a provision in the so-called Affordable Care Act (pp. 49-58). She also rejects administrative-law claims that the Title X regulations are in various respects arbitrary and capricious (pp. 59-81).
