Abortion Pills Don't Just Kill Babies, They're Injuring Thousands of Women

In a victory for women's health, the U.S. Court of Appeals for the Fifth Circuit ruled August 16, in Alliance for Hippocratic Medicine v. U.S. Food and Drug Administration that the FDA must restore critical safeguards for chemical abortion drugs and end illegal mail-order abortions. Although the case remains stayed until the Supreme Court decides to grant or deny any request to hear it, this is a crucial step in protecting women from the dangers of chemical abortion.

In addition to ending the life of an unborn child, chemical abortions can cause serious health risks to women. As the court noted, FDA's own data shows that "thousands of women, and as many as hundreds of thousands, have experienced serious adverse effects as a result of taking the drug, and required surgery or emergency care to treat those effects."

In particular, the most updated medication guide suggests that between 2.9% and 4.6% of women visit the emergency room after taking chemical abortion drugs.

Yet after approving chemical abortion drugs in 2000—under a regulation that required the FDA to find that pregnancy is a serious or life-threatening illness no less—the FDA stripped away every meaningful safeguard. A scared teenager facing an unexpected pregnancy can go online, fill out a form, have mifepristone shipped to her door and ingest the drug all alone, outside the care of a doctor.

The court's decision reinstated crucial safeguards and returned chemical abortion to the original 2000 safeguards, including the seven weeks' gestational limitation, necessary office visits, non-fatal adverse event reporting, and physician dispensation.

And these dangerous drugs may no longer be shipped by mail. This



decision vindicates the handful of brave doctors experienced in caring for pregnant and post-abortive women who are plaintiffs in the case and have been speaking up on behalf of girls and women for years. For decades, these doctors have called attention to the serious risks and complications of chemical abortion, petitioning the FDA to pull chemical abortion drugs from the market, or at the very least, restore necessary safeguards.

Well now, a new era has come. Thanks to the Fifth Circuit's ruling, the FDA will finally be held accountable for its reckless disregard for the law and women's health and safety.

MI Bill Could Put Pro-Life Conservatives in Prison for 5 Years for "Hate Speech"

The Democrat-controlled Michigan House of Representatives has passed an "anti-hate speech" bill that, if enacted, would make it illegal for a person to make any individual "feel terrorized, frightened, or threatened." HB 4474, also known as the "Michigan Hate Crime Act," would replace and expand upon the state's current Ethnic Intimidation Law, which has been on the books since 1988.

As the *Daily Wire* reports: Under the bill's framework, "sexual orientation" and "gender identity or expression" are included as classes protected against intimidation. If passed, the hate speech legislation would make violators guilty of a felony punishable by up to five years in prison and a fine of \$10,000.

Pennsylvania ends decades-long funding for crisis pregnancy centers

Editor's Note: The Governor of Pennsylvania is clearly not "pro-choice" but is clearly pro-abortion.

The state of Pennsylvania announced this month that it would be ending its partnership with a non-profit group that helps fund crisis pregnancy centers throughout the state. The state Department of Human Services said in a press release that its contract with Real Alternatives "will come to an end by Dec. 31, 2023," after nearly 30 years.

Real Alternatives says on its website that it routes funding to a "network of social service agencies, pregnancy support centers, maternity residences, and adoption

agencies that offer comprehensive, life-affirming alternatives to abortion to women dealing with unplanned pregnancies." Among the services offered by the program include counseling, food, shelter, childbirth classes, and other amenities. The organization says it has helped hundreds of thousands of pregnant women and mothers since 1996.

Pennsylvania Gov. Josh Shapiro in the release tied the decision explicitly to support for abortion. "Pennsylvanians made clear by electing me as governor that they support a woman's freedom to choose, and I will be steadfast in defending that right," he said. A representative with Shapiro's office did not respond to a request for comment on the decision. Real Alternatives also did not respond to a query seeking comment, including on whether the state's cancellation would affect its pregnancy outreach operations.

Pennsylvania DHS Secretary Val Arkoosh said in the state's press release that the contract cancellation was "a huge step forward" for the state. Pro-abortion activists regularly criticize crisis pregnancy centers for what they claim are deceptive and manipulative practices; Arkoosh has been an outspoken proponent of abortion in the

In a statement after the state announced the contract termination, Real Alternatives said it was "shocked" to learn of the cancellation, claiming that Shapiro "has been terribly misinformed about the need for the program and its success."

"There has never been a complaint from the 350,000 women we have served" in nearly 30 years, the group said.

"Presently, 83 centers throughout the commonwealth provide compassionate caring support services to 13,500 women a year, from the moment they find out they are pregnant through 12 months after the birth of the baby," the statement said.

The organization claimed its medical referral program in the last fiscal year alone saved the state nearly \$400 million in medical costs.

"[We] have been commended for [our] work by two Pennsylvania governors, three secretaries of the Department of Public Welfare, one United States vice president, and one assistant secretary of the U.S. Health and Human Services in charge of Temporary Assistance for Needy Families," the group said.

The state in its announcement said it would soon begin "soliciting applications for women's health providers across the state to address women's health needs" as a replacement for the Real Alternatives program.
